In becoming an Access Charter School volunteer/chaperone, a criminal history check may be conducted. A prior criminal record may or may not result in your disqualification for volunteering/chaperoning, but a failure to disclose your record on the application **WILL** disqualify you from volunteering/chaperoning.

In Florida, the **entire arrest record** is revealed to school districts by the Florida Department of Law Enforcement and/or FBI, including “sealed” or “expunged” records and “military court proceedings”. Factors such as age at the time of the defense, circumstances of the offense and rehabilitation will be considered when determining the stability for volunteering.

Florida Law requires that you must disclose this information even if you have been told differently by a lawyer, judge, other third party or law enforcement individuals. You must list all convictions, including those in which adjudication was withheld and/or records were sealed or expunged. All convictions must be reported regardless of the number of years since the offense.
